<p><u>Qualifications as an Experienced Organizer</u></p> <ul style="list-style-type: none"> ♦ Proof of experience as a Professional Organizer may include: the CPO® credential or a written summary of one's experience including business start-up date, number of clients and client hours, other credentials, training and previous related work.

<p><u>Experience Being Coached</u></p> <ul style="list-style-type: none"> ♦ Ten mentor coaching sessions (at least 45 min. each) over a minimum of ten weeks with an ICF-credentialed PCC or MCC coach. A major focus must be on training/supervision of core competency coaching skills (ACC level). 	<p>\$500 – 1,500</p>
<p><u>100 Client Coaching Hours</u></p> <ul style="list-style-type: none"> ♦ With a minimum of 35 hours required in each of two categories: coaching that directly relates to an organizing session and stand-alone coaching. ♦ At least 80 of the 100 hours must be paid. ♦ Up to 20 hours may be with a client who is a Coach Approach student, but these hours must be completely separate from any course requirements. 	<p>0</p>
<p><u>Letters of Recommendation</u></p> <ul style="list-style-type: none"> ♦ Two letters of recommendation from an ICF-credentialed PCC or MCC coach. ♦ Alternately, one of the letters may be from a CPO®, CPO-CD®, or COC® organizer familiar with your work as an Organizer Coach. 	<p>0</p>
<p><u>Signed Statements</u></p> <ul style="list-style-type: none"> ♦ <i>The Organizer Coach Code of Ethics</i> ♦ <i>The Statement of Agreement and Compliance</i> 	<p>0</p>

<p><u>Demonstration of Coaching Proficiency</u></p> <ul style="list-style-type: none"> ♦ Two 30-minute coaching sessions: one recorded and one live. 	<p>0</p>
